Introduction

This SEND Policy reflects the principles of the 0-25 SEND Code of Practice (2014). The aims of this special educational needs policy are to:

- Ensure the Equality Act 2010 duties for students with disabilities are met
- To enable students with special educational needs to have their needs met
- To take into account the views of the students with special educational needs
- To encourage good communication and genuine partnerships with parents/carers of children with special educational
- Employ a collaborative approach with learners with a SEN or disability, their families, staff within school, other external agencies including those from Health and Social Care
- To facilitate full access to a broad, balanced and relevant education, including an appropriate curriculum for the foundation stage and the National Curriculum, for students with special educational needs
- To make arrangements to support students with medical conditions and to have regard to statutory guidance supporting students at school with medical conditions
- To implement a graduated approach to meeting the needs of students using the Assess, Plan, Do, Review process, alongside the SEND profiles of need document as prescribed by Surrey SEND
- Develop a culture of inclusion valuing high quality teaching for all learners, with teachers using a range of effective differentiation methods
- Share expertise and good practice across the school and local learning community
- Make efficient and effective use of school resources
- Have regard to the Code of Practice (2014) for the identification, assessment, support and review of special educational needs
- Have regard to guidance detailed by Surrey County Council.
- Have regard for the National Disability Strategy to insure inclusivity and improved opportunity for those students with disability

Our SEND Policy aims to:

- Set out how Bishop David Brown School (BDB) will support and make provision for pupils with special educational needs (SEND)
- Explain the roles and responsibilities of everyone involved in providing for pupils with SEND

This Policy is written in line with the requirements of the Statutory SEND Code of Practice and the following legislation:

- Part 3 of Children and Families Act 2014
- SEN & Disability Code of Practice (DfES/DoH 2015)

The SEND policy sits alongside the SEND Information report which outlines provision and the implementation of the SEND policy. The SEND information report documents the specific provisions in response to the 14 Key questions as provided by Surrey SEND

This policy was developed with the participation and involvement of senior leaders, staff, parents/carers, students and governors and will be reviewed annually.

DEFINITION OF SEND “A child or young person has SEND if they have a learning difficulty or disability which calls for special educational provision to be made for him or her. A child of compulsory school age or a young person has a learning difficulty if he or she: Has a significantly greater difficulty in learning than the majority of others of the same age; or Has a disability which prevents or hinders him or her from making use of facilities of a kind generally provided for others of the same age in mainstream schools or mainstream post-16 institutions.” (DfES/DoH 2015: 15-16)

DEFINITION OF DISABILITY “Many children and young people who have SEN may also have a disability under the Equality Act 2010 – that is ‘...a physical or mental impairment which has a long-term and substantial adverse effect on their ability to carry out normal day-to-day activities’. This definition provides a relatively low threshold and includes more children than many realise: ‘long-term’ is defined as ‘a year or more’ and ‘Substantial’ is defined as ‘more than minor or trivial’.” SEN and Disability Code of Practice (DfES/DoH 2015: 16)

Special educational provision is educational or training provision that is additional to, or different from, that made generally for other students of the same age by mainstream schools.

Pupils who encounter barriers to learning only as a result of speaking English as an additional language are not included in the SEND policy, unless they have additional and identified learning difficult which requires additional special educational provision.

The kinds of SEN for which provision is made

BDB currently provides additional and/or different provision for a range of needs, including:

- Communication and Interaction, for example, Autistic Spectrum Disorder, Asperger's Syndrome, Speech and Language difficulties
- Cognition and learning, for example, Dyslexia, DLD (Dyspraxia), Dyscalculia and Moderate Learning difficulties
- Social, Emotional and Mental Health difficulties, for example, Attention Deficit hyperactivity disorder (ADHD), Oppositional Defiance Disorder (ODD) and Anxiety and Obsessive compulsive disorder (OCD).
- Sensory and/or physical needs, for example, visual impairments, hearing impairments, processing difficulties, epilepsy and those students with physical disabilities.

There are other kinds of special educational need which do not occur as frequently and with which the school is less familiar, but it is possible to source and access training and advice so that these kinds of needs can be met. We can also meet the needs of students for whom an Education, Health and Care Plan has been granted. Decisions on the admission of students with an Education, Health and Care Plan are made by the Local Authority in consultation with the school setting. The admission arrangements for students without an Education, Health and Care Plan do not discriminate against or disadvantage disabled children or those with special educational needs.

1. Information about the policy for identification and assessment of students with SEN

In line with the SEN and Disability Code of Practice (DfES/DoH 2015) Students are identified as either having no SEND; having SEND with Support; or as having SEND with an Education, Health and Care Plan. We continuously monitor and review the progress of all students, as well as collecting more formal grade rounds three times a year. We also continuously review and monitor the broader developmental needs and progress of all students and use a range of assessments with students at various points including CATS and assessment tests for reading and spelling. We will also use less formal methods of assessment including observation, once a member of staff or parent has identified a concern or need. Where progress is not sufficient, even if a special educational need has not been identified, staff are able to provide additional support to help the student to catch up. Where further intervention is required, we provide additional support through the SPIRIT Centre. The Student Support staff are qualified teaching assistants with specialist expertise, in SEND as well as in different subject areas, who are able to provide either small group teaching, or bespoke, individualised support for identified students.

Some students may continue to make inadequate progress, despite high-quality teaching tailored to their areas of weakness. For these students, and in consultation with parents/carers, we will use a range assessment tools to determine the cause

of the learning difficulty. We utilise CATS and 4Matrix to track student's progress. We work closely with our Educational Psychologist who is able to use a range of specific cognitive assessment tools. The purpose of this more detailed assessment is to understand what additional resources and different approaches would be suitable to enable the student to engage fully with the curriculum. These will be shared with parents/carers, put into a SEND plan and reviewed regularly, and refined/revised if necessary, as part of the Graduated Approach (DfES/ DoH, 2015) and Surrey SEND Profiles of Need document. At this point, we will have identified that the student has a special educational need because the school is making special educational provision for the student, which is additional and different to what is normally available. Students will then be identified on our SEND Register as SEND with Support. The register will clearly identify the needs of the young person and strategies to support their learning or development, and will be communicated to all stakeholders in order to ensure clarity and effectively meet the needs of the young person. If a student is removed from the SEND register as they have made significant progress, then careful and continued monitoring will need to take place by both the class teachers and the SENDCO to ensure a substantial and robust process remains and all stakeholders are aware of any changes. If the student is able to maintain good progress without the additional and different resources, they will not be identified with special educational needs. When any change in identification of SEN occurs, parents/carers will be notified.

The students themselves will also play a pivotal role with regard to their support, they will complete with support a one page profile that outlines the student's preferences about how best to support them within the classroom. This will be reviewed annually or when necessary in order to ensure that the student's needs are current and are still being met. This document will be made available to all stakeholders including staff and parents, in order to ensure that all are working together to meet the needs of the individual.

SPIRIT Centre staff will therefore work closely with teachers to ensure that the special educational needs of all students are fully understood, and that where they require ongoing high levels of support to be able to make progress, they are identified on the SEND Register. Where they may have a diagnosis of a special educational need, but have no need for ongoing high-level support to manage that special educational need within the school context, the student's needs will be fully recorded and shared with all staff on the Class Profiles, but they will not be added to the SEND Register. We will ensure that all teachers and support staff who work with the student are aware of the support to be provided and the teaching approaches and strategies (which is also inclusive of the students own views) to be used.

2. Information about policies for making provision for students with special educational needs whether or not they have EHC Plans

How we evaluate the effectiveness of provision for such students

Each review of the SEND support plan will be informed by the views of the student, parents/carers and subject teachers as well as assessment information from teachers, which will show whether adequate progress is being made. The SEN and Disability Code of Practice (DfES/DoH, 2015: 95) describes inadequate progress as:

- “Is significantly slower than that of their peers starting from the same baseline.
- Fails to match or better the child’s previous rate of progress.
- Fails to close the attainment gap between the child and their peers.
- Widens the attainment gap”

For students with or without an Education, Health and Care Plan there will be an annual review of the provision made for the child, which will enable an evaluation of the effectiveness of the interventions that have been implemented. The collation of all annual review evaluations of effectiveness will be reported to the Local Governing Body.

Arrangements for assessing and reviewing the progress of students with special educational needs

Every student in the school has their progress tracked regularly throughout the year. In addition to this, students with special educational needs may have more frequent assessments of reading and spelling ages. Students with SEND will also be regularly observed within the classroom, to ensure that there is a wraparound of care within the assess, plan, do review cycle. Using ongoing assessments, it will be possible to see if students are increasing their level of skills in key areas. If these assessments do not show adequate progress is being made the SEND plan will be reviewed and adjusted.

Our approach to teaching students with special educational needs

‘High quality teaching, differentiated for individual pupils, is the first step in responding to pupils who have or may have SEND. Additional intervention and support cannot compensate for a lack of good quality teaching. Schools should regularly and carefully review the quality of teaching for all pupils, including those at risk of underachievement. This includes reviewing and, where necessary, improving, teachers’ understanding of strategies to identify and support vulnerable pupils and their knowledge of the SEN most frequently encountered’ SEN and Disability Code of Practice’ (DfES/DoH, 2015: 99)

We follow the Teachers Standards to ensure that our teaching conforms to best practice. In meeting the Mainstream Core Standards, we employ some additional teaching approaches, as advised by internal and external assessments e.g. targeted and differentiated work within the classroom using the Know it , Grasp it and think it approach, one to one tutoring/mentoring, small group teaching, use of IT software learning packages, laptops, overlays or any aid that helps to facilitate learning, e.g. ergonomic pens. These are delivered by additional staff employed

through the funding provided to the school as “notional SEND funding”.

How we adapt the curriculum and learning environment for students with special educational needs

We follow the advice in the Teachers Standards on how to adapt the curriculum and the learning environment to create an inclusive environment for students with special educational needs. We also incorporate the advice provided as a result of assessments, both internal and external, and the strategies described in Education, Health and Care Plans.

As part of our requirement to keep the appropriateness of our curriculum and learning environment under review, we ensure that the building is accessible to all whilst providing additional adaptations through the purchase of specialist equipment for physically disabled students where required (e.g. lift and accessible toilets, lift). We also employ carers who work alongside the local physiotherapy and moving & handling team to assist our students with more complex needs. The learning environment is constantly under review to ensure that both the site and the curriculum and extra-curricular activities are accessible to all students.

Additional support for learning that is available to students with special educational needs

As part of our budget we receive “notional SEN funding”. This funding is used to ensure that the quality of teaching is at least good in the school and that there are sufficient resources to deploy additional and different teaching for students requiring SEND support. The amount of support required for each student to make good progress will be different in each case and a full list of the interventions we can offer is on our provision map. In very few cases a very high level of resource is required. The funding arrangements require schools to provide up to £6000 per student with high needs per annum, and above that amount the Local Authority should provide top up to the school.

How we enable students with special educational needs to engage in activities of the school (including physical activities) together with children who do not have special educational needs

Pupils with SEND are continually encourage to participate and be part of the wider school community, be it taking part in extra-curricular activities or as part of the student voice team in order to improve their social and emotional development.

All clubs, trips and activities offered are available to students with special educational needs either with or without an Education, Health and Care Plan. Where it is necessary, the school will use the resources available to it to provide additional adult support to enable the safe participation of the student in the activity. Where possible, additional funding will be accessed to support accessibility for all students, for example, through the purchasing of specialist equipment to enable students with physical disabilities to attend and participate in all trips and activities.

Support that is available for improving the emotional and social development of students with special educational needs

We understand that an important feature of the school is to enable all students to develop emotional resilience and social skills both through direct support, for instance mentoring, and through our delivery of PSHE in assemblies and indirectly with every conversation adults have with students throughout the day. For some students with the most need for help in this area we also provide pastoral support from their pastoral leaders and form tutors, additional mentoring from the Student Support staff team, ELSA (Emotional Literacy Support assistant) and, when needed, support from an educational psychologist, or our EIKON Children's Wellbeing practitioners. Students in the early stages of emotional and social development because of their special educational needs will be supported to enable them to develop and mature appropriately. This will usually require additional and different resources, beyond that required by students who do not need this support. Interventions such as SULP (the Social Use of Language Programme) as well as individualised Transition to Adulthood programmes will be implemented as necessary to support these students.

Pupils within the setting also have open access to the SPIRIT room throughout the school day in order to help with emotional regulation when required; during this time, they are provided with targeted support to reduce stress and anxiety.

3. Roles and Responsibilities

The SENDCO

The SENDCO is Mrs Vicky White who is designated to look after the whole school. She works in school all week and can be contacted by calling the main school number (01932 349696).

She will:

- Work with the Head of School and SEND governor to determine the strategic development of the SEND policy and provision in the school
- Have day-to-day responsibility for the operation of this SEND policy and the co-ordination of specific provision made to support individual students with SEND, including those who have EHCP plans
- Provide professional guidance to colleagues and work with staff, parents, and other agencies to ensure that students with SEND receive appropriate support and high quality teaching
- Advise on the graduated approach to providing SEND support
- Advise on the deployment of the school's designated budget and other resources to meet student's needs effectively
- Be the point of contact for external agencies, especially the local authority and its support services

- Liaise with potential next providers of education to ensure students and their parents are informed about options and a smooth transition is planned
- Work with the Head of School and Governing Body to ensure that the school meets its responsibilities under the Equality Act 2010 with regard to reasonable adjustments and access arrangements
- Ensure the school keeps the records of all students with SEN up to date.
- Complete risk assessments and Personal emergency evacuation plans (PEEPs) where required for students with SEND.

The SEND Governor

The SEND Governor will:

- Help to raise awareness of SEND issues at governing body meetings
- Monitor the quality and effectiveness of SEND and disability provision within the school and update the governing body on this
- Work with the Head of School and SENDCO to determine the strategic development of the SEND policy and provision in the school.

The Head of School

The Head of School will:

- Work with the SENDCO and SEND governor to determine the strategic development of the SEND policy and provision in the school
- Have overall responsibility for the provision and progress of learners with SEND and/or a disability

Class Teachers

Each class teacher is responsible for:

- The progress and development of every student in their class
- Working closely with any Student support assistants or specialist staff to plan and assess the impact of support and interventions and how they can be linked to classroom teaching.
- Working with the SENDCO to review each student's progress and development and help determine any changes to provision that are necessary to support the student to access the curriculum and make progress both academically and socially and emotionally.
- Ensuring they follow this SEND policy.

4. Information about the expertise and training of staff in relation to children and young people with special educational needs and how specialist expertise will be secured

All teachers have attended a full programme of CPD curriculum differentiation and understanding of the roles and responsibilities of the teacher through the SEND and Disability Code of Practice (DfES/ DoH, 2015). Audits of the training acquired by teachers and the perceptions of teachers of their levels of experience and knowledge in relation to all areas of SEND are compiled on an annual basis, and the results are used to regularly review and revisit the training needs of all staff in relation to the evolving needs of students within the school.

Mrs White has taught within both Mainstream and Specialist provisions within Surrey and Berkshire and has extensive knowledge of working with young people who have additional needs. Mrs White holds the National SENDCO qualification along with the Certificate in Psychometric testing, assessment and access arrangements.

Where training needs for staff are identified, we are able to source and find a provider who is able to deliver the required training. Training providers we can approach are, Dyslexia Action, NASEN, and NHS therapy services. The notional SEND funding covers the cost of training.

Staff training for supporting students with SEND within Bishop David Brown School takes place regularly throughout the year. Universally staff are provided with weekly updates within briefing regarding individual students, their needs and the most appropriate strategies to support them within the classroom, in order to ensure Quality First Teaching takes place and the students are then able to meet the demands of their learning. SEND training is delivered to all staff during inset days and CPD twilight training.

Alongside the briefings, bitesize SEND training updates are provided to staff via the staff share, for different types of SEND for example ADHD, ASD, ODD, Speech Language and communication in order to develop understanding of difficulties that students within their classrooms may be facing. This method enables staff to refresh and develop greater understanding within their own time and when necessary.

Targeted SEND training is provided to Members of staff who are either new to the school, Newly Qualified or in training, at the start of a new academic year and this takes place within either the inset days or twilight training sessions. SEND training is delivered by the SENCO and provides an opportunity for staff to improve and develop their own knowledge of SEND and how this influences directly on the students that we have at Bishop David Brown School.

Student support assistants are encouraged to continually develop their own personal knowledge of different aspects of SEND and undertake personal training that supports their knowledge or is relevant to the students that they are working with. They are also able to attend training sessions provided by the local authority when appropriate as well as whole school SEND training sessions.

When required, additional SEND training is provided from agencies who come from outside of the school environment for example the Hearing Impairment service and Speech and Language to help improve practice and develop knowledge and understanding of how best to support, the young people that we work with. This training is tailored to meet the needs of the audience for example teaching or support staff and the cohort of students that we have in school.

The SENDCO also provides specific training and development 1-2-1 with staff when required, to help improve and cultivate better practice within the classroom. This includes making observations as well as providing guidance and strategies for working with individual students. This personalised training is undertaken throughout the year on a needs basis.

Within the school, all staff are encouraged to speak to the SENDCO if there are any underlying concerns or training needs regarding supporting students with SEND, and Vicky White personally holds an extensive library of books and information that the staff can borrow in order to improve practice and support greater understanding of specific needs

5. Information about how equipment and facilities to support children and young people with special educational needs will be secured

Where external advisors recommend the use of equipment or facilities, which the school does not have, we will purchase it using the notional SEND funding, or seek it by loan. For highly specialist communication equipment the school will seek the advice of the Surrey Communication and Assistive Technology team. This will be reviewed annually to ensure that the equipment remains up to date and relevant to the needs of the pupil.

6. Additional Support for Learning

We have 7 teaching assistants who are trained to deliver interventions such as Individual 1-2-1 support both in class and within student support, ELSA, break and lunchtime access to the SPIRIT centre- providing a safe space, access arrangements for public and school exams, Peer reading and maths groups. Social skills and emotional development group through the use of inclusive sports like Boccia. Vicky White also deliver bespoke programmes for small groups, to further develop and improve social skills, anger management and resiliency. The groups take place throughout the academic year to ensure that students with SEND needs are met in order to improve outcomes for these young people.

Two members of the SEND department are also Speech Language, communication ambassadors and will this year receive regular training, and updates, which will be cascaded through the school team to ensure up to date strategies, are being used within the classroom.

We have a trained Mental Health first aider within the department who provides additional support when required

The SEND department also work alongside the EAL co-ordinator to help support those SEND students who also have EAL needs.

7. The arrangements for consulting parents/ carers of children with special educational needs about, and involving them in, their education

All parents/carers are invited to discuss the progress of their child at a parent teacher meeting once a year and grade round reports on academic progress are shared with parents three times a year. In addition, we are happy to arrange meetings outside these times. As part of our normal teaching arrangements, all students will access some additional teaching to help them catch-up if the progress monitoring indicates that this is necessary; this will not imply that the student has a special educational need.

If, following this normal provision, improvements in progress are not seen, we will contact parents to discuss the use of internal or external assessments which will help us to address these needs better. From this point onwards, the student will be identified as having special educational needs because special educational provision is being made and the parent will be invited to all planning and reviews of this provision. Parents will be actively supported to contribute to assessment, planning and review.

Parents/carers of students with SEND will be invited regularly to contribute to the SEND Plan process, where teachers work with the student and parents/carers to identify individualised and appropriate targets for development, and the support and provision needed to achieve that.

In addition to this, parents of students with an Education, Health and Care Plan will be invited to contribute to and attend an Annual Review, which, wherever possible will also include other agencies involved with the student. Information will be made accessible for parents.

8. The arrangements for consulting young people with special educational needs about, and involving them in, their education

When a student has been identified as having special educational needs because special educational provision is being made for him or her, the student will be consulted about and involved in the arrangements made for them as part of person-centred planning. Parents/carers are likely to play a more significant role in the childhood years with the young person taking more responsibility and acting with greater independence in later years. At Bishop David Brown School, we support this through a clear focus on Transition to Adulthood.

9. The arrangements made by the Local Governing Body relating to the treatment of complaints from parents of students with special educational needs concerning the provision made at the school

The normal arrangements for the treatment of complaints are used for complaints about provision made for special educational needs. We encourage parents to discuss their concerns with their child's Head of Year initially to resolve the issue. Parents are also encouraged to contact Vicky White (SENCO) or Mr Rodgers (Head of School) to discuss any concerns that they may have, before making the complaint formal.

There are some circumstances, usually for children who have an Education, Health and Care Plan, where there is a statutory right for parents to appeal against a decision of the Local Authority. Complaints, which fall within this category, cannot be investigated by the school.

10. How the school involves other bodies, including health and social services bodies, local authority support services and voluntary organisations, in meeting the needs of students with special educational needs and in supporting the families of such students

Bishop David Brown School has engaged with the following bodies:

- Disabled Children's Service for support to families for some students with high needs.
- Therapy Services, including ASD outreach and Speech and Language/ Occupational Therapy Services / Physiotherapy Services for students requiring direct therapy or advice.
- Communication and Assistive Technology Team.
- Membership of professional networks for SENCOs e.g. NAS, SENCO forum, NASEN

12. Arrangements for supporting students with special educational needs in transferring between phases of education or in preparing for adulthood and independent living

We work closely with the educational settings attended by the students before they transfer to us in order to seek the information that will make the transition as seamless as possible. At least one member of staff will visit each primary school to discuss with the Year 6 teacher and SENDCO the needs of the students

transferring to us in advance of the two student induction days. Where possible the SENDCO will also attend year 6 annual reviews in order to facilitate transition and get a full picture of the young person. If required, members of the SPIRIT Centre will make additional visits to meet individual students prior to induction days and further in school visits will be timetabled for students felt to be in need of a more comprehensive induction programme.

We also contribute information to a student's onward destination by providing information to the next setting. Teaching staff, in partnership with the careers staff, ensure that all students have clear pathways forward upon leaving. This is achieved through careers meetings, joint visits to other institutions and close liaison with staff providing further education courses.

We liaise closely with, and keep an updated record of local youth workers, charities and voluntary organisations that can support our students with SEND with transition and for preparation for adulthood, as well as having our own Transition to Adulthood programme to support identified students in school.
